 Roll was called by Commission Clerk Gina Volpi, and it was noted that commissioners Steve Booth, Nick Bloise, Sally Ly, and Noah Painter were present and that Commissioner Bruce Nelson was absent. A quorum was declared.

<u>ACTION</u>: Newly elected Chair Bloise nominated Commissioner Painter Vice Chair. No additional nominations were made. Commissioner Painter was elected Vice Chair unanimously (4 to 0).

- 12) <u>Executive Officer's Verbal Report to the Commission</u>

Executive Officer Dowdin Calvillo reported that the Commission's next meeting is scheduled for Friday, August 29 at 1:30pm. Commissioners will likely hear a release from probation appeal.

At the September 5 meeting, Commissioners are tentatively scheduled to hear an Eligible List appeal. Given the complexity of this appeal, it is likely to be only item that will be scheduled besides routine items.

The proposed Alternate Exam for Certified Disabled Persons is tentatively scheduled for introduction, first reading and public hearing at Commission's September 19 meeting and adoption at the October 31, 2025 meeting.

Since the last meeting, the Executive Officer said the Commission received four exam disqualification appeals, one of which was administratively resolved, one was withdrawn and the remaining two were rejected for noncompliance with the Civil Service Rules.

She also closed one failed psychological evaluation appeal after it was withdrawn by the appellant.

Currently, there are five release from probation, one failed psychological evaluation, one failed medical evaluation, and one eligible list appeal pending before the Commission.

Executive Officer Dowdin Calvillo also reported that since the last meeting, she received the 2025 Attorney – Child Support Services Series class study for preliminary review and provided comments on that study as well as the 2025 Assistant County Counsel, and the Child Development Specialist Series class studies.

At this time, there are NO class studies awaiting review by the Executive Officer or action by the Commission.

The proposed schedule for review and adoption of the Rule amendment establishing the Alternate Exam for Certified Disabled Persons is as follows:

- 1) Already drafted by Commission staff and reviewed by Commission Counsel
- 2) Circulate draft Rule to DPS for a 14-day review next week
- 3) If no major revisions are deemed necessary, release first reading notice and forward Rule to unions and County's Disability Advisory Commission for a 14-day pre-review on September 5
- 4) First reading and public hearing at the Commission's September 19 meeting
- 5) If needed, revise Rule. If not, schedule for Commission adoption at the October 31 meeting
- 6) Rule takes effect immediately upon adoption by the Commission no action is needed from BOS
