H. Department Of Personnel Services: Modified Request To Revise The Electronics Technician Classification Specification, Inclusive of Minimum Qualifications (Continued From 11/20/08)

<u>ACTION</u>: By a vote of four to one, approved as recommended by the Department of Personnel Services in their report dated October 20, 2008, and modified in their report dated January 15, 2009:

- Revised the class of Electronics Technician, inclusive of the Minimum Qualifications
- I. Civil Service Commission Executive Officer Request For Directive And/Or Authority
 To Decrease The Number Of Monthly Commission Meetings Held To Lessen
 Anticipated Budget Reduction Impact To Department

During discussion of the proposed \$27,366 midyear budget reduction, the Commission noted that their responsibilities are mandated by the Sacramento County Charter and should be protected and funded accordingly, advising that staff levels should remain whole, with no pay cuts, work hour cuts, or furloughs. That an impact statement should be issued showing the consequences of cuts this extreme to a department this size and how those cuts will impact all other departments if class studies and appeals are delayed because staff is not present full time. The Commission further noted that, like other departments servicing County departments, the Commission should be moved to the Allocated Cost Package and/or be allowed to bill departments for staff time involved in processing class studies and appeals.

<u>ACTION:</u> By unanimous vote, approved the cancellation of the March 6, April 17, May 15, and June 26 meetings for Fiscal Year 2008-09.
